

2023 PSAC NATIONAL EQUITY CONFERENCES

INSTRUCTIONS FOR NOMINATION FORM

Equity Delegates to PSAC Triennial Convention

As per PSAC Constitution Section 19, Sub-Section 7:

The Indigenous Peoples, Racially Visible Persons, Pride, Access and Women equity groups shall each be entitled to send two (2) delegates to any National Triennial Convention of the PSAC who shall be accorded all rights and privileges of accredited delegates. These delegates shall be elected at their respective PSAC National Triennial Conference.

Delegates at the 2023 PSAC National Racially Visible Persons Conference will elect:

 two members as delegates (one of which must self-identify as a woman) to the PSAC National Triennial Convention in 2024 as well as one Alternate to these positions.

NOMINATIONS

To be nominated a member must:

- be a PSAC member in good standing, and
- self-identify from the respective equity group, and
- be nominated and seconded by a member in good standing who also identifies from the respective equity group and is a delegate to the conferences.

NOTE: The nominee, nominator and seconder must all provide a signature showing their agreement.

FOR MEMBERS ATTENDING THE CONFERENCES

Nominations for members in attendance at the conference will close on the floor at the time of elections.

FOR MEMBERS NOT ATTENDING THE CONFERENCES

Nominations may be accepted from PSAC members (in good standing) who self-identify from the respective equity group <u>WHO WILL NOT BE ATTENDING</u> the Conference **no later than Friday, October 13, 2023**.

Nominations submitted prior to the 2023 PSAC National Equity Conferences, in cases <u>WHERE THE NOMINEE IS NOT ATTENDING</u> the Conferences, may be accompanied by a written letter, explaining why the member wishes to be considered for the position. It must be less than 3 minutes long when read out loud.

This letter will be read during the election process by the nominator or the seconder attending the Conference.

Equity Group members not be attending the 2023 PSAC National Equity Conferences are NOT eligible to be nominated at the Conference. The deadline for receipt of nominations from these members is Friday, October 13, 2023.
