- Provide tools and tactics to build personal and collective power to fight for a better future for all women.
- Empower women to build political capacity and activists in the union, the community and beyond.

WORKSHOPS

My Body, My Choice: Advocating for Women's Health

Objectives:

- Educate members on underrepresented and undiagnosed women's health issues in the workplace including menopause, menstruation, and mental health.
- Create strategies to address women's health in the workplace with colleagues and employers
- Discuss how members can continue to advocate for women's health and autonomy

Embracing Intersectionality

Objectives:

- Define intersectionality and present its roots
- Explain the importance of intersectionality in the context of the labour movement
- Discuss different ways to integrate intersectionality in members' work and activism

Past, Present, and Future: Am I a Feminist?

Objectives:

- Define feminism
- Provide an overview of feminism throughout Canadian labour history
- Discuss current and emerging challenges related to women's rights
- Provide information and strategies on collective solidarity and activism for women's rights.

PARTICIPANTS

1. Delegates

Selected delegates will be advised by email on June 30, 2025.

PSAC members in good standing who are women may apply to be a delegate to the Conference. Priority is given to those who are active on women's rights in their union or workplace. Priority will also be given to community activists on women's issues. The selection of delegates will consider Region, Component, language, young workers, and equity group representation.

Delegates are selected by their respective Components and Regions.

Funding for Delegates:

Delegates are entitled to the following:

- travel costs, including ground transportation;
- hotel accommodation costs at the Westin Harbour Castle Hotel;
- loss of salary;
- meals;
- incidental costs; and
- family care as per the Family Care Policy.

2. Observers

PSAC members who are women and in good standing may also attend the Conference as observers. **Observers are responsible for all costs associated with their participation**, including:

- the conference registration fee of \$200;
- loss of salary and meals;
- hotel and travel arrangements;
- incidental costs; and
- family care requirements.

Funding for Observer participation is not available from the PSAC. Please note that the number of observers is limited to the space available at the Conference. **Observers do not have the right to voice or vote during the resolutions debate.**

Members who indicated on their registration form that they wanted to be considered as observers if they were not selected as a delegate will be notified on June 30, 2025.
