INSTRUCTIONS FOR NOMINATION FORM

Delegates Representing Young Workers to the 2024 PSAC National Triennial Convention

The 2022 PSAC National Triennial Convention amended the PSAC Constitution to recognize a National Young Workers Conference in Section 17, Sub-Section (6)(i); and the election of two delegates from the National Young Workers Conference to the PSAC National Triennial Convention in Section 19, Sub-Section (7).

Delegates at the 2023 PSAC National Young Workers Conference will elect:

• two members as delegates to the 2024 PSAC National Triennial Convention as well as one Alternate.

NOMINATIONS

To be nominated a member must:

- · be a PSAC member in good standing, and
- self-identify as a young worker, and
- be nominated and seconded by a member in good standing who also identifies as a young worker and is a delegate to the conference.

<u>NOTE</u>: The nominee, nominator and seconder must all provide a signature showing their agreement.

FOR MEMBERS **NOT** ATTENDING THE CONFERENCE

Please note that nominations may be accepted from PSAC members (in good standing) who identify as young workers who are unable to attend the Conference **no later than April 7, 2023**.

Nominations submitted prior to the 2023 PSAC National Young Workers Conference, in cases where the nominee is not attending the Conference, may be accompanied by a written letter, explaining why the member wishes to be considered for the position. It must be less than 3 minutes long when read out loud.

This letter will be read during the election process by the nominator or the seconder attending the Conference.

FOR MEMBER ATTENDING THE CONFERENCE

Nominations will also be accepted from members attending the Conference. For these members, nominations will close on the floor at the time of elections.
